You should use this packet if:

- 1. You would like to change your name.
- 2. You are not incarcerated in a jail or prison.
- 3(a). You are over 18 years of age and have been a resident of Monroe County,West Virginia for more than one (1) year prior to filing this Petition, or
- 3(b). You are a nonresident of Monroe County, West Virginia but were born in Monroe County, West Virginia, married in Monroe County, West Virginia and previously were a resident of Monroe County, West Virginia for at least 15 years.
- 4. You are not a registered sex offender pursuant to any state or federal law.
- 5. Your are not seeking this name change for any improper or illegal purpose.
- 6. You are not a convicted felon in any jurisdiction.
- 7. You are not attempting to avoid any state or federal law regarding identity.
- 8. This name change is not for purposes of avoiding debt or creditors.

HOW TO FILE THESE FORMS:

You will need to type or print neatly in black ink in the blanks provided. Do
not print on the back or sides of the forms. The Civil Action No. will be
provided by the Clerk's Office.

- 2. Take the original Petition to the Circuit Clerk of the County where you are filing, along with the Legal Notice of Publication. If you do not have access to a Notary Public, bring a picture ID with you and the Clerk's office can notarize the forms after they have witnessed your signature.
- 3. There is a \$145.00 filing fee. The fee must be in the form of cash or a money order made payable to the Circuit Clerk of Monroe County. If you feel you cannot afford the fees, ask the Clerk for a Financial Affidavit to fill out. You may qualify for a waiver of the fees.
- 4. The Circuit Clerk will fill out the Legal Notice of Publication and return the Original to you.
- 5. Contact the local newspaper and make arrangements to publish the Legal Notice of Publication. This notice must be published one time, at least 10 days before the hearing date. Additional fees will be required at the newspaper to cover the cost of publication. If you qualify for a waiver of fees, you may have the newspaper send the bill for the publication to the office of the Circuit Clerk for payment processing. Otherwise, you will need to arrange for payment to the newspaper.
- 6. You must file with the Circuit Clerk's office, either prior to or on the date of the hearing, the Affidavit of Publication that you will receive from the newspaper after publication.
- 7. You must take the Order to your hearing for the Judge to sign. You should be prepared to explain to the Judge the reason for your change of name, and to verify all of the facts contained in the Petition.
- Once the Judge has granted your name change by signing the Order, if your responsibility to inform government agencies, your employer, your creditors, and all other interested agencies and businesses of your new name.
- You will be provided one certified copy of your Order for name change. Additional copies of your Order may be obtained at the Circuit Clerk's Office for a fee of .50 cents per page, which must be paid in the form of cash or a money order.
